Infection Control Policy

EYFS: 3.45, 3.46, 3.46

Abbey Wood Grange aims to maintain high standards of health, hygiene and safety, and the co-operation of parents is essential in this. We do not have the facilities or staff to nurse sick children, who need individual attention, and as a result we ask that all children who are ill be kept away from the Nursery until they have fully recovered.

We have trained first aiders on site in case of accidents. Please ensure your child has the necessary vaccinations and immunisations against childhood diseases at the correct ages.

If a child is unwell, they should not be in any care provision – not only to prevent the risk of infection spreading but also because constant nursing and attention may be needed. If you are requested to collect your child, please come as quickly as possible. Your child will not be accepted back into the nursery until they are fit and healthy, periods of exclusion may be necessary.

It is extremely important that Parents/Guardians of children at the Nursery ensure that their personal contact details are correct. It is your responsibility to inform the Nursery of any changes in these details. Failure to do so could result in lost time trying to contact you in case of an emergency.

Medication

If you are not able to administer medicine at the prescribed time, you need to complete and sign a "Medicine Form" beforehand which authorises a member of staff to administer the medicine on your behalf.

Reportable Infectious diseases will be reported to the Public Health England Team. We ask that you observe these minimum isolation periods and guidance which have been set out by **Public Health England**:

Infection	Recommended period to be kept away from nursery	Comments

COVID 19	If a person is presenting the main symptoms of COVID 'a new continuous cough, fever 38 degrees or above or loss of taste or smell' they are recommended to get tested and stay at home - but not required to self-Isolate *any person presenting just a fever would follow our Fever control measures	Any person who tests positive for COVID 19 are recommended to stay at home but not required to self-Isolate Any close contacts are not required to be tested and or self-isolate, regardless of vaccination status
Diphtheria	Exclusion is essential. Always consult with your local HPT	Family contacts must be excluded until cleared to return by your local PHE Centre. Preventable by vaccination. Your local PHE center will organize any contact tracing
Diarrhea and/or Vomiting	Exclusion for 48 hours from last episode of diarrhea or vomiting	
E.coli O157 VTEC, Typhoid & Shigella	Exclusion is required for children aged 5 years and under until there is evidence of microbiological clearance.	
Fever (Temperature) 38°C (100°F) or over	Your child would need to be collected, Calpol/Nurofen to be administered and taken to the doctors. Exclusion from nursery until the temperature has returned to normal	Under no circumstances can we accept children when Calpol has been given prior to attending nursery Unless it is for teething
Flu	Until recovered	See-Vulnerable Children
German Measles (rubella)	Exclusion for four days from onset of rash	*Preventable by immunisation Dangerous to pregnant women if not immune

Whooping cough	Exclusion for five days from starting antibiotic treatment or 21 days from onset of illness if no antibiotic treatment	Preventable by vaccination. After treatment, non-infectious coughing may continue for several weeks. Our local PHE center will organize any contact tracing if necessary

In addition:

- The nursery manager retains the right of refusal of all children, parents, carers, staff and visitors who are deemed contagious and may impact on the welfare of the rest of the nursery
- Parents will be made aware of the need for these procedures in order for them to follow these guidelines whilst in the nursery
- Periodically each room in the nursery will be deep cleaned including carpets and soft furnishings to ensure the spread of infection is limited. This will be implemented earlier if the need arises
- In the event of an infection outbreak the nursery will, where appropriate, undertake a deep clean to ensure the spread of infection is contained
- We will follow Government health guidance, as well as seeking legal advice and information from our insurers, on any national outbreak of a virus/ pandemic and keep parents informed of any course of action. Each specific circumstance will differ and to ensure we take the most appropriate action; we will treat each case on an individual basis
- In addition, where contagious outbreaks occur, we will adopt Government guidance for all visitors to minimise the risk of further spreading of the infection
- The nursery will ensure stocks of tissues, hand washing equipment, cleaning materials and sterilising fluid are maintained at all times. These will be increased during the winter months, or when flu and cold germs are circulating.
